

Freedom of Information Publication Scheme



Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information, which is to be published in the future. All information in our publication scheme is available via contact with the School Office. Some information which we hold may not be made public, for example personal information. This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

At Billinge Chapel End Primary School we aim to provide a safe, happy and stimulating learning environment In order to achieve this we:

Provide learning environments that are warm, welcoming, secure, child-centred and intellectually stimulating.

Help develop a positive attitude to learning and encourage children to become independent and involved in planning and organising their own learning.

Provide quality teaching that motivates and sustains the children's attention.

Encourage our children to develop lively, imaginative, creative and enquiring minds.

Provide opportunities for our children to question, discuss and apply themselves to tasks and physical skills.

Develop the skills that children need in order to contribute successfully to a constantly changing society.

Develop the moral and social values that children need in order to contribute effectively towards a sustainable environment for future generations.

Encourage the children to value human achievements in all areas including music, sports and the arts.

Develop the potential of every child so they can achieve to the best of their ability

As a result of such an environment we hope our children will leave Chapel End Primary school as healthy, happy, rounded individuals who:

- Have respect for the world and understand their responsibilities as a global citizen in ensuring it is conserved for future generations
- are aware of their place in society and their responsibility to contribute positively to it.
- are polite, well-mannered and helpful
- Have respect and tolerance for others, and their beliefs and cultures.
- possess the skills and knowledge that they require to enable them to continue their learning and achieve their full potential

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The Governing Body– this section sets out information published in governing body documents.

Policies-These are numerous and cover various aspects of school practice and procedures (for a full list of available policies please contact the school office).

Ofsted and school performance -information relating to the school following inspection.
